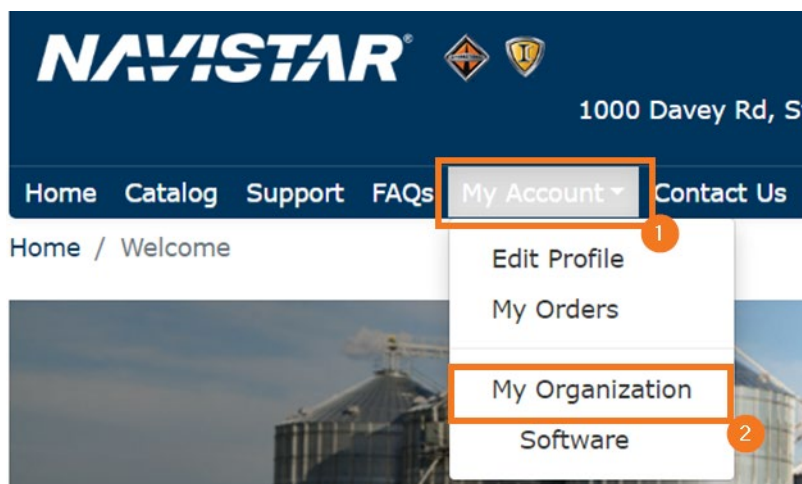

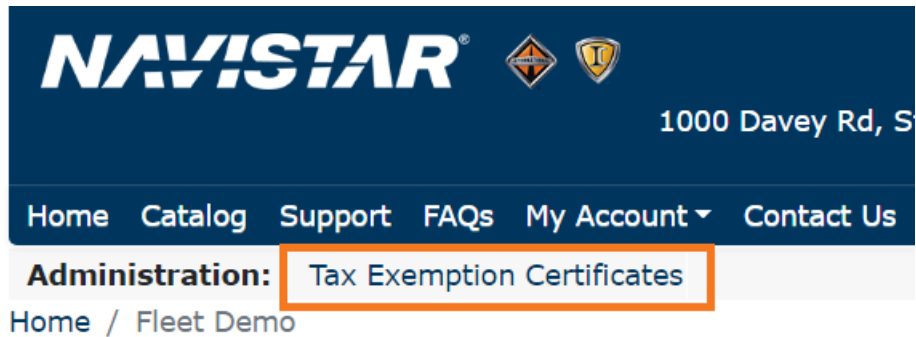

1. Open the **My Account** menu and select **My Organization**.



2. Select **Tax Exemption Certificates.**



3. Attach your certificate, enter the date range the certificate is valid for, then select **Add.**

You may upload a Tax Exemption Certificate as proof that orders placed on behalf of your organization should be treated as tax exempt. This website will set the Estimated Tax to zero for orders that are placed between any Valid From and To date ranges for any uploaded certificates. Our back-end system will STILL CALCULATE THE ACTUAL TAX tax for your orders; This system will take into account any valid Tax Exemption Certificates you have provided. If none are deemed to be valid, YOU WILL BE CHARGED any and all applicable taxes, regardless of what the website shows the estimated tax to be.
